

Sisense sweepstakes

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **SWEEPSTAKES ENTRY START/END DATES:** the sweepstakes identified in the notice linked to these Official Rules (“Sweepstakes”) is sponsored by Sisense, Inc. (“Sisense” or “Sponsor”). The Sweepstakes begins at 12:00:00 am (midnight) Eastern Time on the opening date stated in the notice and ends at 11:59:59 pm Eastern Time on the final date stated in the notice (“Sweepstakes Period”).
2. **ELIGIBILITY:** The Sweepstakes is open to legal residents age 18 and older of the 50 United States and District of Columbia. Void outside the USA, in Puerto Rico, the US Virgin Islands and other United States territories and possessions. Entrants must have either a valid social security number or a valid U.S. personal tax identification to participate. Employees, officers and directors of Sisense, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers and directors are not eligible to enter.
If the notice linked to these General Rules is an email or personal letter sent by Sponsor, participation is by invitation only and limited to the named recipient of the email or letter unless otherwise stated in the notice.

3. **HOW TO ENTER:** During the Sweepstakes Period, participants must follow the instructions in the notice linked to these Official Rules and provide the information required to participate.

You must have an email address to enter; an email address is free. Limit one (1) entry per person/per email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email address, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.

4. **REQUIREMENTS OF ENTRIES:** By entering the Sweepstakes, each entrant warrants and represents that: (a) entrant’s entry does not contain any material or elements violate the rights of any third parties; (b) entrant’s entry is not a duplicate of any other submitted entries; (c) entrant’s entry will not violate any law, rule or regulation or infringe on any rights of any third parties; and (d) entrant’s entry complies with these Official Rules. By submitting an entry, entrant agrees that Sponsor, in its sole discretion, may remove any entry and disqualify an entrant from the Sweepstakes if it believes, in its sole discretion, that the entrant’s entry fails to conform to these Official Rules.

By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of Sponsor, which will be final and binding in all matters relating to the Sweepstakes, including, but not limited to, interpretation and application of these Official

5. **PRIZE SELECTION/ODDS:** The winning entry for the Prize will be chosen according to the terms stated in the notice linked to these General Rules. If no other terms for selecting the winning entry are stated in the notice, or if such terms do not result in a winning entry, then the winning entry will be chosen in a random drawing from all eligible entries received during the Sweepstakes Period. Odds of winning depend on the number of eligible entries received for the drawing fulfilling any terms stated in the notice linked to these Official Rules. Subject to verification of eligibility and compliance with these Official Rules, the winning entry chosen as determined by Sponsor, will be deemed the potential Prize winner.
6. **WINNER NOTIFICATION:** Promptly after the end of the Sweepstakes Period, the potential Sweepstakes winner will be notified via the email address provided by the potential winner. A potential winner must respond to Sponsor's notification within five (5) business days after the date of notification. A potential winner's failure to respond to the Prize notification within the specified five (5) business days will be considered such potential winner's forfeiture of the Prize and an alternate winner may be selected from the pool of eligible entries. If an entrant is found to be ineligible, an alternate winner may also be selected from the pool of eligible entries. A potential winner may be required to sign and return, where legal, a Statement of Eligibility, Liability/Publicity Release and Payment Authorization within seven (7) calendar days of receipt. If such document is not returned within the specified time period, the Prize or Prize notification is returned as undeliverable, or a potential winner is not in compliance with these Official Rules, that potential winner's Prize will be forfeited and an alternate winner will be selected. Upon Prize forfeiture, no compensation will be given. In the event of a dispute as to the identity of any potential winner, Sponsor reserves the right in its sole discretion to select another winner and the unidentifiable potential winner will forfeit all rights to the Prize.
7. **PRIZE:** The Prize(s) are as identified in the notice linked to these Official Rules. The Prize may be subject to further applicable terms and conditions. The Prize is non-transferable. No substitutions or cash redemptions. In the case of unavailability of any Prize item, Sponsor reserves the right to substitute such Prize item with a Prize item of equal or greater value. All unspecified expenses are the responsibility of winner.
8. **PRIZE DETAILS:** Taxes and/or or any other expenses not specifically stated in the Prize description are the responsibility of Prize winner. The Prize is awarded "as is" with no warranty or guarantee, either express or implied. The winner is responsible for all applicable federal, state and local taxes, if any, as well as any other costs, gratuities and expenses associated with Prize acceptance and use not specified herein as being provided. Where applicable, taxes may be withheld by Sponsor and Sponsor shall have no obligation to adjust the Prize or otherwise compensate the winner for any taxes withheld. The winner agrees to furnish Sponsor with and/or execute any additional documents requested by Sponsor in connection with the awarding of the Prize.

The parties agree not to raise the defense of forum non conveniens. The Sweepstakes is void where prohibited by law. All federal, state and local laws and regulations apply.
